Rationale/Background

Global epidemiological data on diabetes and diabetes-related complications provide a holistic view of the impact of diabetes and health outcomes for people living with the condition. However, there are many gaps in these data, particularly in low- and middle-income countries, where the diabetes burden is increasing most. Through data collection, we can bridge these gaps and foster a comprehensive approach to diabetes care.

Diabetes registries hold the potential to improve care and treatment in clinical settings significantly. These collaborative platforms bring together researchers, healthcare professionals, clinicians and people with diabetes. By sharing real-world patient data, registries can identify treatment patterns and quality of care and prevent or delay diabetes-related complications, ultimately reducing healthcare costs and ensuring better patient outcomes.

Raising awareness of the need for registries among healthcare professionals and the public is the starting point for better diabetes management and treatment plans. Healthcare professionals can include real-world data ranging from the impact of diabetes to management plans and quality of care in their clinical practice. In low- and middle-income countries, registries can offer a holistic view of the condition and help estimate the resources needed to tackle it. Furthermore, this data can inform policies that advocate for better quality of care, standardise early diagnosis and prevent complications.

- **Promote** the expansion of diabetes registries, fostering a comprehensive approach to care, especially in low- and middle-income countries.

- Share tips to advocate for the development of national diabetes registries.
