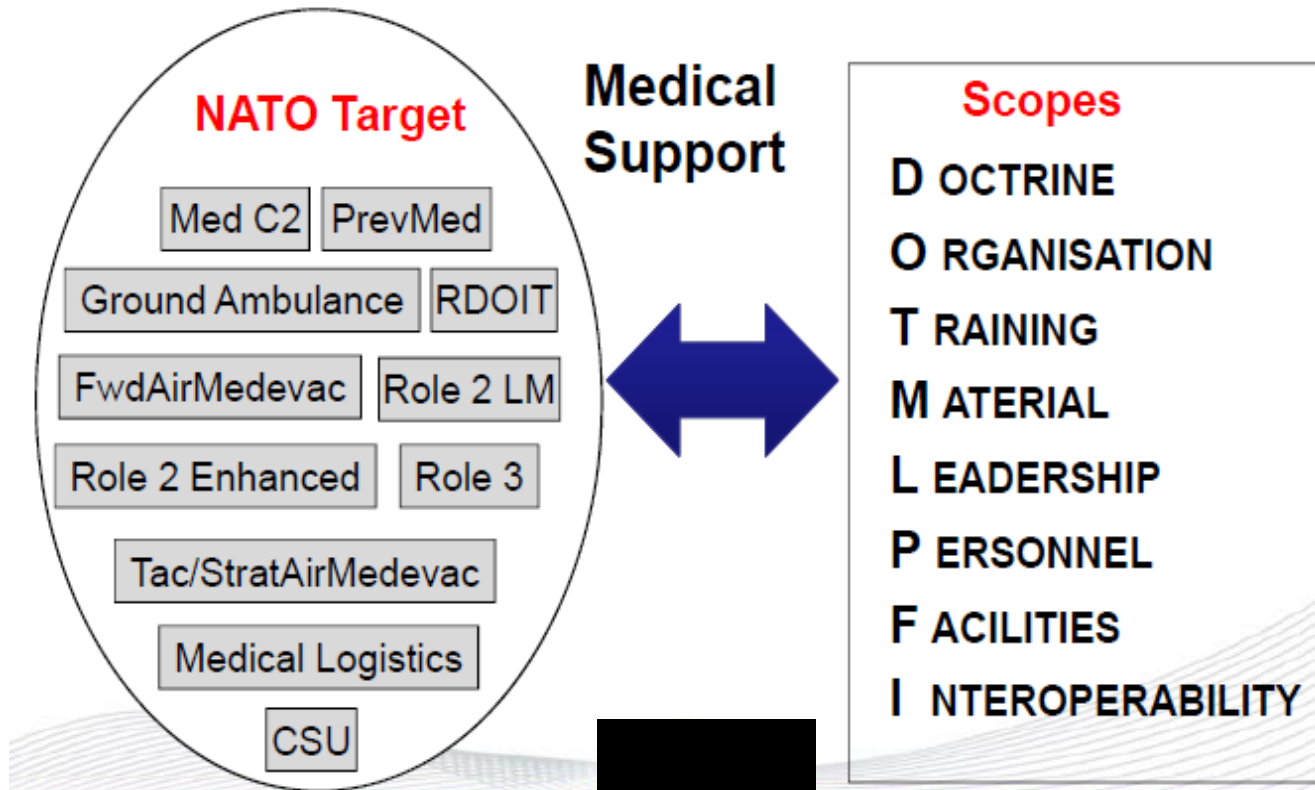

Framework Nations Concept – medical elements

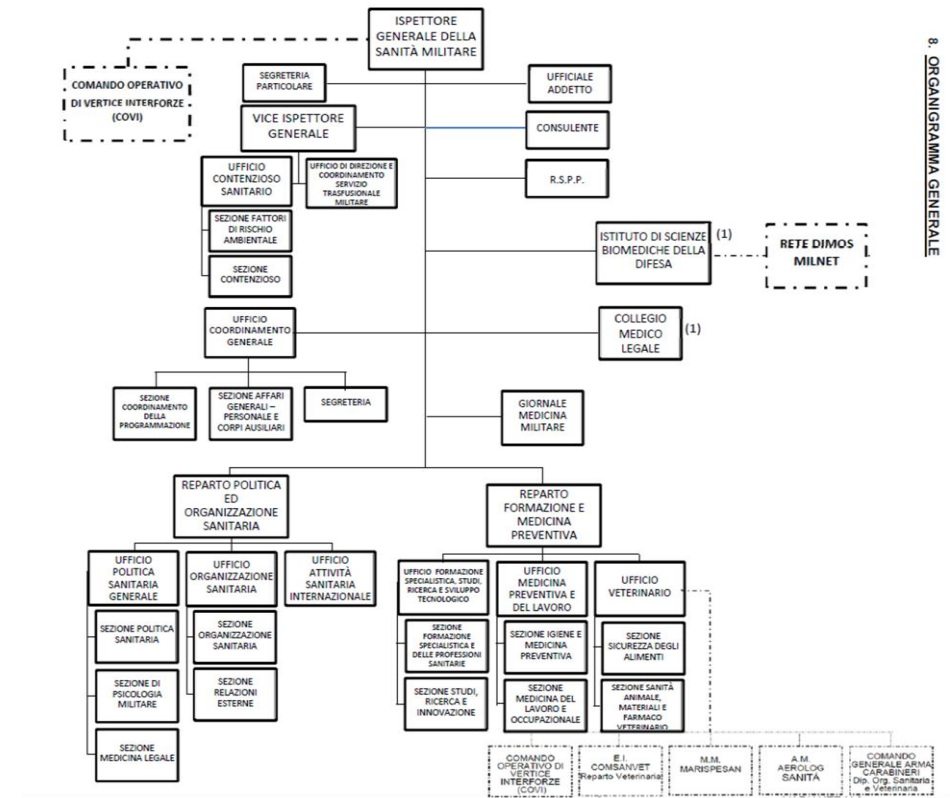

Inspector General of Military Medical Services

The General Inspectorate of Military Medical Services is responsible for directing and coordinating military health services and activities. It also manages the training of military and civilian medical, technical, and specialized personnel for both central and peripheral units.

IGESAN is the Advisory organization of the Chief of Defense Staff on health-related matters.

It is led by a General Officer from the Medical Corps of the Armed Forces or Carabinieri, with the rank of Lieutenant General or equivalent.

The Inspector General of Military Medical Services represents the Chief of Defense Staff in dealings with the National Health Service, the Department of Civil Protection, the Italian Red Cross (Military Corps and Voluntary Nurses Corps), the Sovereign Military Order of Malta (ACISMOM), and any other national and international bodies competent in the field, as well as coordinates with the relevant bodies of the Armed Forces and the Carabinieri.

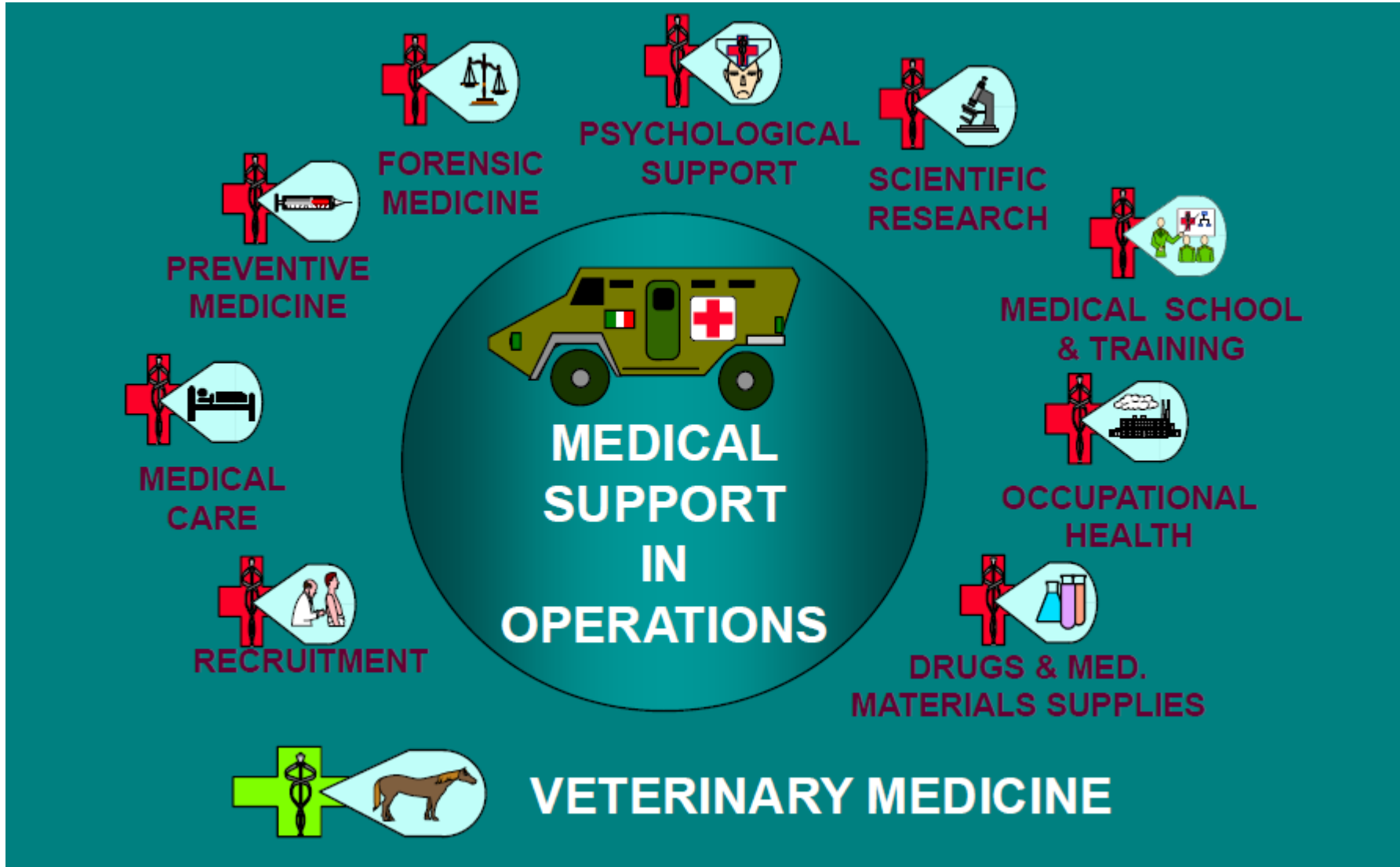
Inspector General of Military Medical Services

The General Inspectorate of Military Medical Services, in coordination with the Defense Staff, Joint Operations Command, and the Armed Forces/Carabinieri:

- Develops joint directives for Military Health aspects, to be issued by the Chief of Defense Staff.
- Studies and evaluates issues concerning Military Health as a whole.
- Verifies the suitability of the joint territorial military health organization.
- Assesses, verifies, and coordinates **health-related research and studies** within the Defense sector.
- promotes and coordinates actions for the development and implementation of **telemedicine** projects in the military field;
- develops, promotes, and updates joint military health doctrine;
- coordinates, in agreement with other relevant bodies, the needs concerning the **education of military health professionals**;
- carries out health and **epidemiological monitoring** activities for military and civilian personnel of the Ministry of Defense;
- fulfills the direction and coordination of the Military Blood Transfusion Service;
- handles technical and health-related legal process.
